**PROPOSED BONUS ISSUE OF UP TO 53,975,000 NEW ORDINARY SHARES IN THE CAPITAL OF AEDGE GROUP LIMITED ON THE BASIS OF ONE (1) BONUS SHARE FOR EVERY TWO (2) EXISTING ORDINARY SHARES IN THE CAPITAL OF THE COMPANY HELD BY SHAREHOLDERS**

**1. INTRODUCTION**

The board of directors (the "**Board**" or "**Directors**") of Aedge Group Limited (the "**Company**") is pleased to announce that the Company is proposing a bonus issue (the "**Proposed Bonus Issue**") of up to 53,975,000 new ordinary shares in the capital of the Company (the "**Bonus Shares**"), on the basis of one (1) Bonus Share to be credited as fully paid for every two (2) existing ordinary shares in the capital of the Company ("**Shares**") held by shareholders of the Company ("**Shareholders**") as at the record date (the "**Record Date**") to be determined by the Board for the purpose of determining the entitlement of Shareholders under the Proposed Bonus Issue, fractional entitlements to be disregarded.

**2. TERMS OF THE PROPOSED BONUS ISSUE**

**2.1 Bonus Shares**

2.1.1 The actual number of Bonus Shares to be issued by the Company will be determined based on the total issued share capital of the Company as at the Record Date. Based on the existing issued share capital of the Company comprising 107,950,000 Shares as at the date of this announcement, up to 53,975,000 Bonus Shares will be issued pursuant to the Proposed Bonus Issue (assuming there is no change in the number of issued Shares from the date of this announcement up to the Record Date). Accordingly, the enlarged share capital of the Company will increase to up to 161,925,000 Shares as a result of the completion of the Proposed Bonus Issue. The Company does not have any treasury shares or subsidiary holdings as at the date of this announcement.

2.1.2 The Bonus Shares will be allotted and issued as fully paid at nil consideration to entitled Shareholders without capitalisation of the Company's reserves. The Bonus Shares, when allotted and issued, will rank *pari passu* in all respects with the existing Shares and with each other, except that the Bonus Shares will not be entitled to any dividends, rights, allotments or other distributions, the record date of which falls on a date prior to the date on which the Bonus Shares are allotted and issued.

2.1.3 The Bonus Shares represent 50% of the existing issued share capital of the Company as at the date of this announcement and approximately 33.33% of the enlarged issued share capital of the Company following the completion of the Proposed Bonus Issue, assuming there is no change to the total issued share capital of the Company as at the Record Date.

**2.2 General Mandate**

2.2.1 The Bonus Shares will be issued pursuant to the share issue mandate ("**General Mandate**") granted by the Shareholders by way of an ordinary resolution at the annual general meeting of the Company held on 28 October 2025 ("**2025 AGM**"). The General Mandate authorises the Directors to, *inter alia*, allot and issue new Shares on a *pro rata*

basis to existing Shareholders, provided that such number of new Shares to be issued does not exceed 100% of the total number of issued Shares (excluding treasury shares and subsidiary holdings) as at the date of the 2025 AGM.

2.2.2 As at the date of the 2025 AGM, the Company had 107,950,000 Shares in issue (there being no treasury shares or subsidiary holdings) and accordingly, the Company may issue up to 107,950,000 new Shares under the General Mandate on a *pro rata* basis.

2.2.3 As at the date of this announcement, the Company has not issued any new Shares pursuant to the General Mandate and accordingly, the issuance of the 53,975,000 Bonus Shares will fall within the maximum number authorised under the General Mandate.

## 2.3 Approvals

The Proposed Bonus Issue is subject to, *inter alia*, the approval of the Singapore Exchange Securities Trading Limited ("**SGX-ST**") for the listing and quotation of the Bonus Shares on the Catalist board of the SGX-ST (the "**Catalist**"). The Company will make an application through its sponsor to the SGX-ST for the dealing in, listing of and quotation for the Bonus Shares on the Catalist in due course. The Company will make the necessary announcement upon receipt of the listing and quotation notice from the SGX-ST.

## 2.4 Compliance with the Catalist Rules

2.4.1 Pursuant to Rule 838 of the SGX-ST Listing Manual Section B: Rules of Catalist ("**Catalist Rules**"), an issuer must satisfy the SGX-ST that the daily weighted average price of its shares, adjusted for the bonus issue, will not be less than S\$0.20 (the "**Minimum Price**"). In compliance with Rule 838 of the Catalist Rules, the issuer should compute such adjusted price based on the proposed bonus issue ratio and the lowest daily weighted share price of its shares for the one-month period preceding the issuer's proposed bonus issue application.

2.4.2 For illustration purposes only and assuming that the Proposed Bonus Issue application has been made on 4 March 2026, being the date of this announcement, the lowest daily weighted average price of the Shares for the one-month period preceding 4 March 2026 would be S\$0.3004 and accordingly, the theoretical ex-bonus price ("**TEBP**") would be calculated as follows:-

$$\begin{aligned} \text{TEBP} &= \frac{\text{S\$0.3004}}{3} \times 2 \\ &= \text{S\$0.2003} \end{aligned}$$

2.4.3 Accordingly, the TEBP will be above the Minimum Price. Further, the Company confirms that there is no reason to believe that the TEBP is likely to fall below S\$0.20 for the one-month period preceding the date of the application to the SGX-ST for the listing and quotation of the Bonus Shares on the Catalist.

## 2.5 Record Date

The Bonus Shares will be issued to Shareholders whose names appear in the Register of Members of the Company or the records of The Central Depository (Pte) Limited, as the case may be, as at the Record Date to be determined by the Board for the purpose of determining the entitlements of Shareholders under the Proposed Bonus Issue. Notice of the Record Date will be

given at a later date, after all the necessary approvals in respect of the Proposed Bonus Issue (including, without limitation, the approvals from the SGX-ST) have been obtained.

### **3. RATIONALE FOR THE PROPOSED BONUS ISSUE**

The Company is proposing the Proposed Bonus Issue to increase the issued share capital base of the Company to reflect the growth and expansion of its business and to reward and give due recognition to Shareholders for their loyalty and continuing support for the Company. In addition, the Proposed Bonus Issue, if carried out, will increase the number of Shares in issue, which may enhance the affordability and accessibility of the Shares to a broader base of investors and potentially improve trading liquidity and overall market participation in the Shares.

### **4. INTERESTS OF DIRECTORS AND SUBSTANTIAL SHAREHOLDERS**

None of the Directors and substantial Shareholders of the Company has any interest, direct or indirect, in the Proposed Bonus Issue other than through their respective shareholdings in the Company, if any.

### **5. RESPONSIBILITY STATEMENT**

The Directors collectively and individually accept full responsibility for the accuracy of the information given in this announcement and confirm after making all reasonable enquiries that, to the best of their knowledge and belief, this announcement constitutes full and true disclosure of all material facts about the Proposed Bonus Issue, the Company and its subsidiaries, and the Directors are not aware of any facts the omission of which would make any statement in this announcement misleading.
