FY2015 vs. FY2014

Revenue

The Group's revenue increased by RMB 53.0 million (or 8%) to RMB 702.1 million. This was mainly due to the increase in the sales of the Trading segment (RMB 92.6 million). The increase was partially offset by the decrease in revenue contributions from the Zipper Chain segment (RMB 23.0 million), the Zipper Slider segment (RMB 8.0 million) (collectively referred as the "Zippers segment"), and the Processing segment (RMB 7.9 million).

The inter-segment sales elimination represented the dyeing and electroplating services provided by the Processing segment to the Zippers segment.

The decrease in revenue from the Zipper segment and the Processing segment were attributable to a deteriorating market for the zipper industry in the PRC which was adversely affected by the general slowdown in the global economy. This had resulted in the decrease in sales order from customers.

The Group's Trading segment relates to the sourcing and buying of certain raw materials in accordance to customers' requirements. The profit margin and all purchases were based on confirmed sales. As such, the volume of trading depends on the opportunities available so as the profitability and price movements which are dependent on customers' demand for raw materials. The increase in revenue from the Trading segment was due to an increase in sales orders from customers during FY2015.

Gross Profit and Gross Profit Margin

The Group's gross profit decreased by RMB 2.6 million (or 5%) to RMB 48.1 million. The decrease was due mainly to the decreases in profit margin from the Processing segment.

Average gross profit margin decreased by 0.9 percentage points to 6.9% due to the decrease in gross profit margin from the Processing segment in FY2015. This was attributable to the decrease in sales orders.

Other income and other expenses

Other income mainly comprises gain on fair valuation from investment properties, government subsidies, and foreign exchange gains. The net income represented the decrease in gain on fair valuation from investment properties (RMB 12.7 million). The foreign exchange gain arises from the depreciation of RMB against USD and SGD in the Group's foreign currencies denominated bank balances and from the translation of HK dollar denominated balances owing from subsidiaries in the Company's book due to depreciation of RMB against HK dollar.

Selling and distribution expenses

Selling and distribution expenses increased by RMB 0.4 million (or 5%) to RMB 7.3 million. The increase was due mainly to the new promotional activities that had commenced in 3Q2015.

General and administrative expenses

General and administrative expenses increased by RMB 12.7 million (or 27%) to RMB 59.2 million. This was mainly due to the allowance for inventory written down of RMB 2.0 million, allowance for doubtful prepayment written off of RMB 5.1 million, and written off of property, plant and equipment of RMB 5.3 million.

The Company written off the spare plant and machineries, after successfully installation of the automation machineries in FY2015.

The Company written off the long-term prepayment more than one year with certain suppliers as the Company had lost contact with the suppliers.

The written down of inventory value represented the decrease in raw materials price.

Finance income and expenses

Finance expenses increased by RMB 1.9 million (or 16%) to RMB 13.9 million. This was attributable to the increase in short-term loans and bills transactions with banks. Finance income decreased by RMB 0.3 million (or 15%) to RMB 1.8 million due mainly to the decrease in interest rate.

4Q2015 vs. 4Q2014 (3 months)

Revenue

The Group's revenue decreased by RMB 11.7 million (or 5%) to RMB 205.2 million. The decrease was due mainly to the decrease in sales of the Zipper Slider segment (RMB 0.7 million), and the Zipper Chain segment (RMB 9.4 million) (collectively referred as the "Zippers segment"), the Trading segment (RMB 1.7 million), and the Processing segment (RMB 2.0 million).

The inter-segment sales elimination represented the dyeing and electroplating services provided by the Processing segment to the Zippers segment.

The decrease in revenue from the Zippers segment and the Processing segment were attributable to a deteriorating market for the zipper industry in the PRC which was adversely affected by the general slowdown in the global economy. This had resulted in the decrease in sales order from customers.

Gross Profit and Gross Profit Margin

The Group's gross profit increased by RMB 2.3 million (or 21%) to RMB 13.1 million. The increase in gross profit was due mainly to the decrease in overhead after partial automation of the production process in the Zipper segment.

Average gross profit margin increased by 1.4 percentage points to 6.4% due to the increase in gross profit margin from the Zippers segment in 4Q2015 arising from lower overhead cost after partial automation of the production process.

Other income and other expenses

Other income mainly comprises gain on fair valuation from investment properties, government subsidies, and foreign exchange gains. The net income represented the decrease in gain on fair valuation from investment properties (RMB 12.7 million). The foreign exchange gain arises from the depreciation of RMB against USD and SGD in the Group's foreign currencies denominated bank balances and from the translation of HK dollar denominated balances owing from subsidiaries in the Company's book due to depreciation of RMB against HK dollar.

Selling and distribution expenses

Selling and distribution expenses increased by RMB 0.3 million (or 18%) to RMB 2.1 million. The increase was due mainly to the new promotional activities that had commenced in 3Q2015.

General and administrative expenses

General and administrative expenses increased by RMB 16.6 million (or 215%) to RMB 24.3 million. This was mainly due to the allowance for inventory written down of RMB 2.0 million, allowance for doubtful prepayment written off of RMB 5.1 million, and written off of property, plant and equipment of RMB 5.3 million.

The Company written off the spare plant and machineries, after successfully installation of the automation machineries in FY2015.

The Company written off the long-term prepayment more than one year with certain suppliers as the Company had lost contact with the suppliers.

Finance income and expenses

Finance expenses decreased by RMB 1.4 million (or 22%) to RMB 5.0 million. This was attributable to the decrease in interest rate. Finance income decreased by RMB 0.2 million to RMB 0.3 million as a result of decrease in interest rate.

FINANCIAL POSITION

Non-current assets

As at 31 December 2015, non-current assets amounted to RMB 695.1 million comprising property, plant and equipment, investment property, land use rights, prepayment and intangible assets.

The Group's property, plant and equipment amounted to RMB 285.2 million, a decrease of RMB 38.8 million compared to RMB 323.9 million as at 31 December 2014. The decrease was due mainly to depreciation expenses.

As at 31 December 2015, the investment properties represented the recognition of the construction cost of the Group's Xiamen Headquarters project ("HQ Project") under FRS40 - "Investment property is property held to earn rentals or for capital appreciation or both." According to the Group's construction plan, the HQ Project will have 25 floors, and most of the office units will be leased out to earn rental income. Therefore, this property including the land use right was classified as investment properties under FRS40.

The decrease in land use rights and intangible assets was due mainly to the amortization expenses.

The prepayment balance in FY2015 represented the deposits paid for purchases of machinery.

Current assets

As at 31 December 2015, current assets amounted to RMB 775.4 million, an increase of 0.4% (RMB 3.0 million) compared to RMB 772.4 million as at 31 December 2014. This was due largely to the increase in cash and bank balances, trade and other receivables.

Inventories decreased by RMB 9.9 million as a result of the decrease in raw materials price.

Trade and other receivables increased by RMB 13.4 million from RMB 269.6 million to RMB 283.0 million due to an extension of credit period granted to some long time customers so as to retain their orders.

The decrease in prepayments to suppliers by RMB 25.9 million (or 28%) to RMB 65.1 million was due mainly to the decrease in advances made to certain suppliers. For advances to suppliers, the Group will secure signed supply agreements with its various suppliers. The advance payments in the supply agreements are calculated based on a certain percentage of the total contract price.

Cash and bank balances increased from RMB 285.7 million to RMB 328.6 million due mainly to the increase in short-term bank loans.

Current liabilities

As at 31 December 2015, total current liabilities were RMB 694.0 million, an increase of 10% (or

RMB 64.7 million) compared to RMB 629.3 million as at 31 December 2014. This was mainly attributable to the increase in trade payables, other payables and accruals, short-term bank loans, and bank overdrafts, which was offset by the decrease in amounts due to a Director, and bills payable to banks.

Trade payables increased by RMB 3.9 million due mainly to the full utilization of the credit period.

The other payables and accruals increased by RMB 24.2 million to RMB 228.3 million was due mainly to the accrual of the construction costs for the building of the Group's Xiamen Headquarters.

Short-term bank loans increased by RMB 56 million (or 24%) to RMB293.2 million due to proceeds from new banking for working capital, please refer to page 4 for further information.

Bank overdrafts represented the drawdown of the banking facilities from Hang Seng Bank.

The amount due to a Director was due to funds contributed by Mr Hong Qing Liang for the Group's Xiamen Headquarters construction project. The construction costs were paid by Mr Hong from his personal bank account in Hong Kong first and reimbursed by the Company. This arrangement was undertaken as the local government of Xiamen Island will impose an interest tax on all monies transferred from other locations within the PRC. Remittances from Hong Kong and foreign countries are exempted from such tax.

Non-current liabilities

Non-current liabilities comprise deferred tax liabilities. The increase in deferred tax liabilities was due mainly to the increase in withholding tax as explained above under the note for tax expense.

CASH FLOW

Operating activities

Net cash flows generated from operating activities in FY2015 amounted to RMB 46.5 million while net cash flows used in operating activities in FY2014 amounted to RMB 9.3 million. This was due mainly to the decrease in prepayments, the increase in trade and other payables.

Net cash flows generated from operating activities in 4Q2015 amounted to RMB 70.8 million compared to RMB 44.5 million in 4Q2014. This was due mainly to the decrease in inventories, increase in trade and other receivables.

Investing activities

Net cash flows used in investing activities in FY2015 amounted to RMB 76.5 million compared to RMB 77.8 million in FY2014; and net cash flows used in investing activities in 4Q2015 amounted to RMB 32.4 million compared to RMB 54.0 million in 4Q2014. This was mainly due to the construction cost of investment properties.

Financing activities

Net cash flows generated from financing activities in FY2015 amounted to RMB 71.6 million compared to RMB 102.6 million in FY2014; and net cash flows generated from financing activities in 4Q2015 amounted to RMB 22.0 million compared to RMB 8.3 million in 4Q2014. This was due mainly to new short-term bank loans and banking facilities obtained, please refer to page 3 for further information.

For the year ended 31 December 2015, the Group recorded a loss of RMB17.2 million after tax. The past year has been a challenging and tough year for the Group as it continued to operate under a highly competitive environment as the zipper industry in the PRC faces intense competition with razor thin profit margins.

The Group expects the zipper industry to remain highly challenging and competitive. The Group expects the continuation of the slowing economic growth in the PRC, uncertainties for export sales, as well as cost pressures arising from rising production and labour costs to prevail. These factors will still adversely impact on the Group's operating outlook for the next twelve months.

The Group expects its current automation of its plant and machineries to yield some cost savings in its overheads so as to mitigate some of the rising cost pressures. The Group will also step up its promotional activities to increase its sales orders and continue to exercise tight control on the administrative expenses.

Update on construction progress of the Company's Xiamen Headquarters

As of to-date, the HQ Project is approximately 85% completed. The Group will strive to complete the construction of the building in the coming months. Upon completion of the construction, the Group will lease out part of the office building for rental income. The Group had obtained shareholders' approval on 28 April 2015 to dispose part of the office building of the HQ Project when opportunity arises which will strengthen its financial position.
